Mr. Justice Muhammad Khurshid Alam Sarkar Hon'ble Judge of High Court Division Supreme Court of Bangladesh

Mr. Justice Muhammad Khurshid Alam Sarkar is a Judge of the High Court Division of Bangladesh Supreme Court. Mr. Justice Sarkar was born on 1 March 1972. He completed his Bachelor's degree and Masters in law from the University of Dhaka. He also completed a second law degree from the United Kingdom. Mr. Justice Sarkar became a lawyer of the district courts on 1 April 1995. On 7 March 1996, Mr. Justice Sarkar became a lawyer of the High Court Division of Bangladesh Supreme Court. On 24 August 2010, he became a lawyer of the Appellate Division of Bangladesh Supreme Court. He was appointed an Additional Judge of the High Court Division of Bangladesh Supreme Court on 20 October 2011. Mr. Justice Sarkar was made a permanent judge of the High Court Division on 7 October 2013. In July 2021, he appointed a board of directors and chairperson for the International Leasing and Financial Services Limited. In October 2021, Mr. Justice Sarkar appointed a four-member team to manage Evaly, an e-commerce site which was going through financial crises.



Professor Dr. Mizanur Rahman

Director, Bangladesh Institute of Law and International Affairs (BILIA) & Former Chairman

National Human Rights Commission of Bangladesh

Professor Dr. Mizanur Rahman is an educationist and currently the Director of Bangladesh Institute of Law and International Affairs (BILIA). Professor Rahman holds a PhD from the Friendship University, Moscow, Russia and has completed his LLM in International Law from the same University. He is a former Fulbright Scholar and the founder coordinator of Professional Legal Education in Bangladesh. He was the professor at the Faculty of Law, University of Dhaka, Bangladesh. Professor Rahman served as the Chairperson of the National Human Rights Commission from 2010-2016. He currently serves as the Director of Centre for Advanced Legal Studies (CALS) at the University of Dhaka, the President, ELCOP (Empowerment through Law of the Common People) and the Advisor, South Asian Network for Justice Education (SANJI).



His efforts with ELCOP earned him the Best Law Teacher in South Asia Award in 2010 and the much coveted Excellence in Legal Education in South Asia Award in 2018 from the Society of Indian Law Firms (SILF) and Menon Institute of Legal Advocacy Training. He has also been a consultant for The World Bank, Government of Bangladesh, Ford Foundation (USA), Soros Foundation (USA), Save the Children-UK, Save the Children-Denmark, NORAD and the European Commission.



Dr. Mahfuzul HaqueAdjunct Professor of Department of Sociology
Bangladesh University of Professionals (BUP), Dhaka
& Former Secretary, Government of the People's Republic of Bangladesh

Dr Mahfuzul Haque, a former Secretary of the Government of Bangladesh has been teaching for a decade and a half in different public and private universities taking courses on environment and development, sustainable development, natural resources management, climate change, biodiversity conservation, natural disaster management, and indigenous knowledge and practices.

He joined civil service in 1981. During his decade-long stint at the Ministry of Environment and Forests, he received on the job training home and abroad on environmental conservation, natural resource management and environmental laws and compliance. He led official Bangladesh delegation at the Conference of Parties of various conventions, including UNFCCC, CBD, Montreal Protocol, Ramsar Convention etc. He was elected as the President of Montreal Protocol Implementation Committee; and Vice President of CBD Bureau based in Montreal, Canada.

He is a prolific writer and extensively contributed in various journals home and abroad. He has authored books on ethnic issues in South Asia, Climate Change, and Street Children. He also contributed articles in peer-reviewed journals on issues related to sustainable environment, natural resources management, bio-diversity conservation, global warming, ozone layer depletion, desertification and environmental laws. His latest book titled "Environmental Governance: Emerging Challenges for Bangladesh" published in 2013 looked at the crises of environmental governance in Bangladesh. A recent published book by Routledge in 2016 titled, Governance in South Asia carried his article on "Shipbreaking Industries in Bangladesh". His contribution on "Environmental Governance" has been published online in June 2017 in The Global Encyclopaedia of Public Administration, Public Policy, and Governance both in print and online versions.





Dr. Ahmed Mushtaque Raza ChowdhuryVice-Chairperson & Adviser to the Chairperson, BRAC

Dr. Chowdhury is the Vice-Chair of BRAC, one of world's largest non-governmental organisations. Previously, he was its Executive Director, founding Director of the Research and Evaluation Division and founding Dean of the James P. Grant School of Public Health at BRAC University. Dr. Chowdhury is also a professor at the Mailman School of Public Health, Columbia University, During 2009-2012, he served as a senior adviser to the Rockefeller Foundation, based in Thailand. He is on the boards of several organisations and initiatives, including the South Asia Centre at London School of Economics and is current chair of Asia-Pacific Action Alliance on Human Resources for Health (AAAH). He was a coordinator of the UN Millennium Task Force on Child Health and Maternal Health. He is a recipient of the 'Innovator of the Year 2006' award from the Marriott Business School of Brigham Young University, the PESON oration medal from Perinatal Society of Nepal in 2008 and Outstanding Leadership Award from Dhaka University Statistics Department Alumni Association. He has a wide interest in development, particularly in the areas of education, public health and poverty eradication. Dr Chowdhury holds a PhD from the London School of Hygiene and Tropical Medicine, an MSc from the London School of Economics and a BA from the University of Dhaka.



Dr. Shahdeen Malik Advocate, Supreme Court of Bangladesh

Dr. Shahdeen Malik studied LLM in Patrice Lumumba University, Moscow and the University of Pennsylvania Law School Philadelphia and holds a PhD from the School of Oriental and African Studies, University of London, UK. He started his career as a Lecturer in the Department of Law at the University of Dhaka in 1980.

He was the founder Director and Professor of the BRAC University, School of Law till 2015. Dr. Malik worked as an Adjunct Professor of the Department of Law and Human Rights, University of Asia Pacific. Over the years, Dr. Malik has



worked as a short-term consultant for a number of UN Agencies (UNDP, ILO, UNICEF) and other bilateral and multilateral development partners (The Asia Foundation, Asian Development Bank, World Bank, Canadian International Development Agency, and others).



Professor Dr. Nakib Mohammad Nasrullah Faculty of Law University of Dhaka

Dr. Nakib Muhammad Nasrullah is currently working as a Professor of Law at the University of Dhaka. Dr. Nasrullah was awarded International Macquarie University Research Excellence Scholarship (iMQRES) for PhD in Investment Law. He completed MPhil in Law from Macquarie University, Australia, in 2009, LL.M in International Law from University of New South Wales, Australia, in 2000, LL.M. and LL.B. (Honours) from University of Dhaka, Bangladesh in 1990 and 1989 respectively. He also has a Diploma in International Humanitarian Law from NALSAR University of Law, India, and a Diploma in Foundation in Learning and Teaching from Macquarie University, Australia. His area of research interest includes International Trade, Finance and Investment Law, Humanitarian Law, Human Rights, International Business Transaction and International Commercial Arbitration.



Dr. Syeda Sultana RaziaProfessor
Department of Chemical Engineering
Bangladesh University of Engineering and Technology (BUET)

Dr. Syeda Sultana Razia is a Professor in the Department of Chemical Engineering, Bangladesh University of Engineering and Technology (BUET). She has served as the Head of the department for two terms. She has been appointed as a member of the Scientific Advisory Board of the Organization for the Prohibition of Chemical Weapons (OPCW), The Hague, Netherlands. She completed her B.Sc. and M.Sc. in Chemical Engineering, from BUET and Ph.D. in Chemical Engineering from the University of Alberta, Canada.



Her expertise includes process safety, chemical safety, and security, distillation and separation processes, effluent treatment, etc. She is an editor of Process Safety and Environmental Protection, a leading journal of process safety of Elsevier and also a member of the Editorial Advisory Board of ACS Chemical Health and Safety, a prestigious journal of American Chemical Society. She has served as an expert in a number of policymaking, investigation, and selection committees dealing with technological issues of chemical industries formed by the Government of Bangladesh. Dr. Razia is a resource person of the National Authority of Chemical Weapon Convention (BNACWC), Armed Force Division, Bangladesh. Dr. Razia is a member of the Global Advisory Team of Poland-based International Center of Chemical Safety and Security (ICCSS). She is also leading collaborations between BUET and Mary Kay O'Connor Process Safety Centre, Texas A& M University System, US.



Mr. Mozammel Hossain KC Barrister-at-Law

Mr. Mozammel Hossain KC is one of youngest barristers to have been appointed as Queen's Counsel. He was sworn in on 11th March at a ceremony at the Westminster Hall at the Houses of Parliament.

After completing the academic and vocational stages of his Barrister training, Mr. Mozammel Hossain KC was called to the Bar by the Honourable Society of Inner Temple. He then completed his pupillage at 187 Fleet Street. He was the first overseas student to become the president of the Students' Union of the Inns of Court School of Law (ICSL). During 1999-2000, he was a governor of ICSL. Mr. Hossain KC has been described by the Court of Appeal as an advocate of 'great eloquence'. He mainly practices criminal law, and has been involved in many high profile criminal cases in the UK.





Mr. Mohammad Nur Khan Executive Director & Member Executive Committee Ain o Salish Kendra (ASK)

Mr Mohammad Nur Khan has been involved in Human Rights movement of Bangladesh for last three decades. He is an active Human Rights defender and has been involved in awarness about Extra- Judicial killings, Enforce Disappearances, Freedom of Expression, Minority Rights, Custodial Torture, and Border Killing. Mr. Khan has been working with Rohingya community before the influx in 2017. He is an avid advocate in providing formal education to Rohingya population. He collects information on the human rights violence carried out against Rohingyas, such as rape, custodial tortures, and murders and so on in Rakhaine, Myanmar. He is closely associated with the Arakan Rohingya Society for Peace and Human Rights (ARSPH) to improve their capacity building so that they can raise their voice. He is one of the founder members of "MAYER DAK", an organisation of family members of the victims of enforced disappearances, extra- judicial killings and custodial tortures. Mr. Khan is engaged in observing and monitoring closely the religious extremists' activities for the last two decades.

Ms Hafiza joined BRAC in 1990 and is currently the director of the Gender Justice and Diversity and the Migration programmes.
